Further, candidates with the roll numbers arranged in ascending order (not in order of merit) given below are provisionally shortlisted for Verification of Documents / Certificates & genuineness of candidature and Medical Examination in order to fill the shortfall in empanelment Pay Level 3 due to Absent, Rejection, Unifit in Medical Standard etc. Candidates are advised to report to the office of Railway Recruitment Board, Guwahati, Panbazar, Station Road, Guwahati 781001, as per scheduled date and time mentioned below.

2.0 SMS / E-mail alerts are being sent to the candidates' registered mobile / email ID for downloading their e-call letter from the official website of RRB, Guwahati. 3.0 Candidates have to upload their signature, latest photograph and identification marks in the portal https://oirms-ir.gov.in/rrbdv/.
