NOTICE FOR CANDIDATES SHORTLISTED FOR COMPUTER BASED TYPING SKILL TEST (CBTST)**

1. The 2nd Stage Computer Based Test (CBT-II) was held on 20th December, 2025.
2. The results of CBT-2 were declared on 23.01.2026 and published in the official Websites of RRBs.
3. The CBTST for Shortlisted candidates on the basis of 2nd Stage Computer Based Test (CBT-II) is tentatively scheduled on **13.02.2026**.
4. The LINK for viewing the Exam City & Date and downloading of Travelling Authority for SC/ST candidates will be made available on RRB websites 10 days prior to the Exam.
5. Downloading of E-Call letters will start 4 days prior to exam date mentioned in Exam City and date intimation link.
6. **The Shortlisted candidates for CBTST will have to type in English or Hindi, as per option exercised by them on official RRB websites. The Shortlisted candidates for CBTST should exercise their option for Typing Language of either English / Hindi, through the link given in the official website of RRB. If the candidate does not choose the typing Language within the stipulated time or for those who have not exercised their option the default Language for typing will be ENGLISH. Candidates who have opted Hindi for Typing Test must be familiar with the usage of Krutidev or Mangal font.**
7. **Procedure and Link for selection of typing language is given below:**
 - (i) Link - <https://dc4-g22.digialm.com/EForms/configuredHtml/2667/95125/login.html>
 - (ii) Login to the portal using your credentials.
 - (iii) Click on the "Language for CBTST" tab.
 - (iv) Select the Plus (+) icon to expand the options.
 - (v) Select the Language Preference for Typing Skill Test (English/Hindi).
 - (vi) Click "Submit" to confirm and save your selection.

The option for selection of typing language is valid up to 07.00 PM of 03.02.2026.

8. **Candidates are advised to choose the language option carefully. Option once exercised, cannot be changed under any circumstances. No further correspondence will be entertained in this regard.**
9. In terms of para 13.4 of CEN 06/2024 the shortlisted PwBD candidates, who are permanently disabled due to Blindness/Low vision, Cerebral Palsy and Locomotor Disability with not less than 40% permanent disability may be exempted for CBTST, provided they upload a scanned copy of Typing Skill Test exemption certificate issued by the Competent Medical Board (constituted by Central or State Government) in the format prescribed in **Annexure V(E)** of CEN 06/2024.
10. The help desk link: <https://dc4-g22.digialm.com/EForms/configuredHtml/2667/95125/login.html> for uploading of scanned copy of Typing Skill Test exemption certificate will be provided in the official website of respective RRBs. The shortlisted PwBD candidates are advised to upload valid Typing Skill Test exemption certificate through **grievance/helpdesk portal using candidate login from 29.01.2026 to 11.02.2026 (up to 07:00 PM.)**. The proforma of Typing Skill Test exemption certificate is enclosed and also available as **Annexure V(E)** of CEN 06/2024.

For Uploading Exemption certificate:

- **Select Problem category:** Typing Skill test
- **Sub-category:** exemption Certificate
- **Formats should be in JPG or PDF**
- **Max file size must be within 5MB**

11. Those candidates unable to upload the certificates, may report at the allotted CBTST venue along with the Original Typing Skill Test exemption certificate for seeking exemption.
12. The candidates are required to produce the same Typing Skill Test exemption certificate in Original during Document Verification, failing which his/her candidature will be summarily rejected.
13. Aadhaar linked Biometric authentication of candidates will be done in the exam center prior to entry into the exam hall. Candidates are required to bring their original Aadhaar card.
14. Candidates are advised to refer only to the official websites of RRBs for latest updates on the recruitment process. Please do not be misled by unauthenticated sources.
15. Beware of touts who try to misguide candidates with fake promises of appointment for jobs on illegal consideration. RRB selections are based on Computer Based Test (CBT) and recruitment is based only on the merit of the candidates.

Note : : (i) According to the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full participation) Rules, 18 (1) 2017, notified on 14.03.2024 by the Central Government in exercise of the powers conferred by sub-Section (i) and (ii) of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 2017, authorities to give disability Certificate will be a Medical Board duly constituted by the Central or the State Government. The State Government may constitute a Medical Board consisting of at least three members out of which at least one shall be a specialist in the particular field for assessing locomotor / hearing and speech. (ii) The certificate would be valid for a period of 5 years for those whose disability is temporary. For those who acquired permanent disability, the validity can be shown as permanent'.
