CEN 02/2024 (TECHNICIAN) - NOTICE FOR MEDICAL APPEAL (PAY LEVEL - 5)

After Document Verification (DV) for the posts of Technician Grade – I in Pay Level – 5 of CEN No. 02/2024 (Technicians), conducted on 08.04.2025 and 09.04.2025 for Level – 5, candidates were sent for Medical Examination to the nominated Railway Hospitals by this office.

Based on the Medical Fitness assessed by the nominated Railway hospital Authorities and Medical board, the following 03 (Three) nos. of candidates for Level – 5 have been found **UNFIT** in the prescribed medical categories for the post applied by them, as a result of which they have not been empaneled.

Candidates, who want to prefer appeal against the decision of the medical committee concerned may submit an appeal for medical re-examination as per format enclosed (Annexure B) addressed to the Pr. Chief Medical Director, N.F. Railway, Maligaon, Guwahati – 781011 routed through Chairman, Railway Recruitment Board, Guwahati on or before 1700 hours of 15.06.2025 with relevant documents by speed post or delivered by hand.

Please note if the candidate fails to appeal within the stipulated period, no additional time will be given.

Also, please note that appeals are usually considered only in exceptional case of error in the Medical Examination and Report.

PROCEDURE OF APPEAL: -

Such an appeal shall be entertained, only if,

- (i) Appeal with justification duly signed by the candidate indicating his/her Roll no., Registration no. & Date of Document Verification is received within 15.06.2025 in the office of the undersigned.
- (ii) The candidate should produce a certificate in the attached prescribed format (Annexure A) from a Government/Private Doctor of the Specialty/specialties in which the candidate has been found Unfit.
- (iii) Such certificate should contain a note that the Government/Private Specialist is fully aware of the physical and visual standards sent by the Railways for the particular medical category, and that he is aware of the fact that you have already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board comprising of three Senior Railway Doctors appointed by the Government in the regard.
- (iv) The certificate should bear the photograph and mark of identification of the candidate duly attested by such a Government/Private issuing Authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and its MCI/State Registration Number.
- (v) Moreover, in terms of Railway Board's letter no. 2014/H/5/8(policy) dated 31.12.2015, candidates declared unfit upon medical examination submitting appeal to PCMD are required to pay Rs. 1000/- through DD payable in favour of **PFA, N.F. Railway, Maligaon**. In case the appeal is considered and decision changes from Unfit to Fit, the DD submitted to Railway will be refunded to the candidates. In all other cases, the DD will be credited to Railway in same head where medical examination fee is deposited.
