**PROFORMA FOR EXEMPTION CERTIFICATE FOR PwBD CANDIDATES SHORTLISTED FOR  
COMPUTER BASED TYPING SKILL TEST (CBTST)**

1. The 2nd Stage Computer Based Test (CBT-2) was held on 13th October, 2025. The results were published on 15th December, 2025. The CBTST for shortlisted candidates is tentatively scheduled on 28-12-2025.
2. In terms of para 13.4 of CEN 05/2024 the shortlisted PwBD candidates, who are permanently disabled due to Blindness/Low vision, Cerebral Palsy and Locomotor Disability with not less than 40% permanent disability may be exempted for CBTST, provided they upload a scanned copy of Typing Skill Test exemption certificate issued by the Competent Medical Board (constituted by Central or State Government) in the format prescribed in **Annexure V(E)** of CEN 05/2024.
3. The shortlisted PwBD candidates who seek exemption of CBTST should upload the scanned copy of Typing Skill Test exemption certificate issued by Competent Medical Board.
4. The help desk link for uploading of scanned copy of Typing Skill Test exemption certificate will be provided in the website of respective RRBs. The shortlisted PwBD candidates are advised to upload valid Medical certificate through **grievance/helpdesk portal using candidate login from 19.12.2025 to 26.12.2025 (up to 18:00 hrs.)**. The proforma of Typing Skill Test exemption certificate is enclosed and also available as **Annexure V(E)** of CEN 05/2024.

**For Uploading Exemption certificate:**

- **Select Problem category:** Typing Skill test
  - **Sub-category:** exemption Certificate
  - **Formats should be in JPG or PDF**
  - **Max file size must be within 5MB**
5. Those candidates unable to upload the certificates, may report at the allotted CBTST venue along with the Original Typing Skill Test exemption certificate for seeking exemption.
  6. The candidates are required to produce the same Typing Skill Test exemption certificate in Original during Document Verification, failing which his/her candidature will be summarily rejected.
  7. Candidates are advised to refer only to the official websites of RRBs for latest updates on the recruitment process. Please do not be misled by unauthenticated sources.
  8. Beware of touts who try to misguide candidates with fake promises of appointment for jobs on illegal consideration. RRB selections are based on Computer Based Test (CBT) and recruitment is based only on the merit of the candidates.

कंप्यूटर आधारित टाइपिंग स्किल टेस्ट (सीबीटीएसटी) हेतु शॉर्टलिस्टेड पीडब्ल्यूबीडी अभ्यर्थियों के लिए छूट प्रमाण पत्र का प्रोफार्मा।

1. द्वितीय चरण कंप्यूटर आधारित टेस्ट (सीबीटी-2) का आयोजन 13 अक्टूबर, 2025 को किया गया था। इसका रिजल्ट 15 दिसम्बर, 2025 को प्रकाशित किया गया था। शॉर्टलिस्टेड किए गए अभ्यर्थियों के लिए सीबीटीएसटी परीक्षा संभावित रूप से 28.12.2025 को निर्धारित है।
2. सीईएन 05/2025 के पैरा 13.4 के अनुसार, शॉर्टलिस्ट किए गए पीडब्ल्यूबीडी अभ्यर्थी जिनका स्थायी दिव्यांगता 40% से कम नहीं है एवं वे अंधापन/कम दृष्टि, सेरेब्रल पाल्सी और लोकोमोटर दिव्यांगता के कारण स्थायी रूप से दिव्यांग हैं, उन्हें सीबीटीएसटी से छूट दी जाती है, बशर्ते कि वे सक्षम मेडिकल बोर्ड (केंद्रीय या राज्य सरकार द्वारा गठित) द्वारा सीईएन 05/2024 के अनुलग्नक V(E) में निर्धारित प्रारूप में जारी की गई स्किल टेस्ट छूट प्रमाण पत्र की स्कैंड कॉपी को अपलोड करें।
3. शॉर्टलिस्ट किए गए पीडब्ल्यूबीडी अभ्यर्थी जो सीबीटीएसटी से छूट चाहते हैं, उन्हें सक्षम मेडिकल बोर्ड द्वारा जारी टाइपिंग स्किल टेस्ट छूट प्रमाण पत्र की स्कैंड कॉपी अपलोड करना चाहिए।
4. टाइपिंग स्किल टेस्ट छूट प्रमाण पत्र की स्कैंड कॉपी अपलोड करने के लिए हेल्पडेस्क लिंक संबंधित आरआरबी की वेबसाइट पर उपलब्ध करा दिया जाएगा। शॉर्टलिस्ट किए गए पीडब्ल्यूबीडी अभ्यर्थियों को सलाह दी जाती है कि वे 19.12.2025 से 26.12.2025 को 18:00 बजे तक कैंडिडेट लॉगिन का उपयोग करके शिकायत/हेल्पडेस्क पोर्टल के माध्यम से वैध मेडिकल प्रमाण पत्र अपलोड करें। टाइपिंग स्किल टेस्ट छूट प्रमाण पत्र का प्रोफार्मा संलग्न है और सीईएन 05/2025 के अनुलग्नक V(E) के रूप में भी उपलब्ध है।

छूट प्रमाण पत्र अपलोड करने के लिए:

- समस्या श्रेणी चुनें: टाइपिंग स्किल टेस्ट
  - उप-श्रेणी : छूट प्रमाण पत्र
  - प्रारूप जेपीजी या पीडीएफ में होने चाहिए
  - अधिकतम फाइल का साइज 5 एमबी के भीतर होना चाहिए
5. जिन अभ्यर्थियों को प्रमाण पत्र अपलोड करने में असमर्थ है, वे छूट प्राप्त करने के लिए आवंटित सीबीटीएसटी परीक्षा केंद्र पर मूल टाइपिंग स्किल टेस्ट छूट प्रमाण पत्र के साथ उपस्थित हो सकते हैं।
  6. अभ्यर्थियों को दस्तावेज सत्यापन के दौरान टाइपिंग स्किल टेस्ट छूट प्रमाण पत्र की वही मूल प्रति प्रस्तुत करना होगा, ऐसा ना करने पर उनकी उम्मीदवारी तत्काल रद्द कर दी जाएगी।
  7. अभ्यर्थियों को सलाह दी जाती है कि वे भर्ती प्रक्रिया से संबंधित नवीनतम अपडेट के लिए सिर्फ आरआरबी की आधिकारिक वेबसाइटों का ही देखें। कृपया अप्रमाणित स्रोतों से गुमराह ना हो।
